Xero Updates

Xero Analytics & Analytics Plus

Xero Analytics is free with all business editions of Xero (Starter, Standard, Premium), giving you simple dashboards to track cashflow and profitability.

Xero Analytics Plus is free for business editions until January 2022 and then \$7.50 +GST per month (\$10 less our 25% Gold Partner discount). Predict future cashflow, run scenarios, deep dive into your data.

Xero Fees Increase

Xero fees are increasing from 23 September 2021, between \$1 and \$3 plus GST per month. Addons like Payroll and Projects. If you have a current Xero discount or promo code, it will continue to be applied to the new pricing, until the discount or code expires. Check that you are on the correct subscription plan for your business, and make sure that you are using Hubdoc and other free features to their fullest.
